2. This is not confirmed booking. Plots will be allotted through balloting. In case of unsuccessful ballot, Down Payment will be refunded; Processing charges are non-refundable. In case of successful ballot, no amount will be refundable.
3. If allottee fails to pay installment within specified time allotment will be liable to cancellation after a one month notice period and paid amount will be forfeited and will be NON-REFUNDABLE.
4. Plot once allotted or transferred cannot be surrendered being NON REFUNDABLE
5. The size and location of the plot is tentative and subject to adjustment after demarcation/measurement of the plot at time of handing over possession.
6. Incase of extra land with any plot, extra amount will be changed in addition to the total amount.
